An adult is regarded as being unable to achieve an outcome when s/he:

a) Is unable to achieve the outcome without assistance. *NB. It also includes where the adult may need prompting [Guidance 6.106]*

- b) Is able to achieve the outcome without assistance but doing so causes the adult significant pain, distress or anxiety.
- c) Is able to achieve the outcome without assistance, but doing so endangers or is likely to endanger the health or safety of the adult, or of others.
- d) Is able to achieve the outcome without assistance but takes significantly longer than would normally be expected.

The term "**significant**" is not defined by the regulations, and must therefore be understood to have its everyday meaning [Guidance 6.110]
